## **DART Seeks Public Input on Reimagine DART Network Redesign**

In April, central Iowans are invited to weigh in on the future of public transit.

The Des Moines Area Regional Transit Authority (DART) is inviting central Iowans to share their perspectives on two concepts for redesigning the regional bus network. In April, community members are encouraged to explore these concepts and provide input through a short survey at [reimagineDARTdsm.com](https://reimagineDARTdsm.com). Feedback collected will guide the DART Commission as it decides priorities and budget for the regional network design.

"This is a unique opportunity for residents, riders and community leaders to help shape the future of public transit in Greater Des Moines," said City of Des Moines Mayor and DART Commission Chair Connie Boesen. "Every citizen's input is critical to informing how we design a transit network that best serves our growing and diverse communities within the reality of current budget constraints."

Established 20 years ago as a regional bus network, DART has continuously evolved to meet changing travel needs. Now, in response to post-pandemic travel changes and budget limitations, the Reimagine DART initiative seeks to boldly reassess services and chart a new path forward. This effort is designed to shape a shared vision for public transit's future – one that maximizes resources and ensures access to essential destinations across Greater Des Moines.

DART and planning staff from several member communities worked with consultants to develop two distinct concepts to help guide the future transit network. These concepts illustrate how you would design a transit network differently to achieve different goals with one goal being high ridership (getting lots of people to ride the bus) and the other goal being high coverage (reaching as many places as possible).

- **Ridership Concept:** Focuses on fewer, high-frequency routes that operate most of the day and week in areas with the most people and jobs.
- **Coverage Concept:** Expands the total number of routes, providing access to a broader geographic area, with less frequent service.

These concepts, along with a short survey, are available online at [reimagineDARTdsm.com](https://reimagineDARTdsm.com) through the end of April. Additionally, DART will host eight public meetings across the region to gather feedback and engage residents.

"DART is committed to providing the best service possible with the resources we have," said DART CEO Amanda Wanke. "This comprehensive look at our entire network is critical to ensuring our service meets people's needs, maximizes the return on investment for central Iowa taxpayers and enhances economic growth in the communities we serve."

Nearly 60% of rides on DART help people get to and from work. These rides are essential to the region's economy – staffing businesses, hospitals, schools, grocery stores, restaurants and other services residents depend on and enjoy. This means everyone benefits from public transit – whether they know someone who uses DART or not. A significant number of DART riders have lower income, have a disability or do not have a valid driver's license or car in their household, which means DART is often their only option to travel.

All feedback collected will be shared with DART's governing board, the DART Commission, comprised of an elected leader from each of DART's member communities. The Commission, which sets DART's budget and policies that determine how DART staff deliver services, will provide direction in mid-May on how to prioritize ridership and coverage in the Draft Network that will be shared for public input in August.
